ARTICLE 1. UNIFORM OFFENSE CODE

11-101. INCORPORATING UNIFORM PUBLIC OFFENSE CODE. There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Ozawkie, Kansas, that certain code known as the "Uniform Public Offense Code." Such code used shall always be the most current edition as prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. No fewer than three copies of said Uniform Public Offense Code shall be marked or stamped "Official Copy as Incorporated by the Code of the City of Ozawkie, Kansas," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this section, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. ARTICLE 2. LOCAL REGULATIONS

- 11-201. **REMOVING BARRICADES.** That it shall be unlawful for any person or persons to remove, throw down, run over, or interfere with any barricade or barricades erected by the City, or any contractor executing a municipal contract, placed to guard and protect any grading, paving, sidewalk construction or other public work, and any person or persons who shall violate the provisions of this Section shall, upon conviction thereof, be deemed guilty of a misdemeanor.

- 11-202. **MOLESTING UNFINISHED PAVING.** That no person or persons shall walk upon, drive or ride over or across any pavement, in course of construction before the same has been opened for public travel, any uncompleted grading, or sidewalk construction which has not been opened for travel. (10-203; Code 2007)
- 11-203. **POSTING BILLS.** That no person shall put up any hand bills, advertisements, posters, show bills, or other sign on any building, pole, or property not his own, without permission from the owner thereof. (10-210; Code 2007)
- 11-204. **RIDING VEHICLES ON SIDEWALK.** That no person shall ride or cause to be ridden upon the sidewalks of this City, any vehicle, including bicycles and motorcycles. (10-215; Code 2007)
- 11-205. **EXPLOSIVES; DISPOSAL OF.** That it shall be unlawful for any person, firm or corporation to sell, give away or otherwise dispose of any detonating explosive without keeping a record as required by law. It shall also be unlawful for any person, firm or corporation to sell, give away or otherwise dispose of any of the explosives named above to any intoxicated or irresponsible person; and when said explosives shall lawfully be in the possession of any person, firm or corporation, they shall be handled in accordance with the general Statutes of Kansas, and no person having in his possession any explosives, shall carry the same in a wholly or partially, concealed manner on or about his person. - 11-206. **STORAGE OF EXPLOSIVES.** It shall be unlawful for any person, firm or corporation to bring into, keep or store, within the corporate limits of the City of Ozawkie, modern gun powder, or black powder (for ammunition loading purposes) in quantities of more than fifteen (15) pounds, or dynamite or other explosives in "ANY" quantity.
