ORDINANCE NO. 18-01

AN ORDINANCE AMENDING CHAPTER XV, ARTICLE 1, SECTIONS 15-1A03 AND 15-1A04 OF THE CODE OF THE CITY OF OZAWKIE, KANSAS REGARDING UTILITY BILLING DATES AND DELINQUENCIES AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OZAWKIE, KANSAS:

SECTION 1: Section 15-1A03 of the City Code of the City of Ozawkie is hereby amended to read as follows:

- 15-1A03. UTILITY BILLING DATES; DELINQUENCY DATE. Utility billings shall be mailed on approximately the 3rd day of each month for the previous month serviced. All billings for utility services shall be due and payable at the office of the city clerk upon receipt and must be paid in full not later than the 27th day of the month. Should the 27th day fall on a weekend or holiday then the due date shall be the following Monday or non-holiday. Payment for utility service not received prior to the 27th day of the month, weekend or holidays excepted, shall be delinquent. A delinquent charge of fifteen percent (15%) will be added to each delinquent utility bill. (Code 2016; Ordinance 18-01)
- 15-1A04. NONPAYMENT OF UTILITY BILLS. (a) An account delinquency and service discontinuance notice shall be issued in writing following delinquency with respect to any delinquent and unpaid utility service bill. Notice shall be sent by U.S. mail, first class, to the customer (and a copy also sent by U.S. mail, first class, to the occupant of the premises served if the occupant is not the customer) at the last known address of the customer as shown on the records of the city. Written notice may also be provided by personal service upon the customer by an employee of the city.
 - b) The notice of account delinquency and service discontinuance shall provide the following information:
 - Name of customer and address where service is being provided.

Account number.

Amount past due plus delinquency charge.

- Notice that utility service shall be terminated upon failure to pay the delinquent billing within ten (10) days of the date of the mailing of the notice or the day following the hearing, whichever last occurs.
- Notice that the customer has the right to appear and be heard at a hearing on the hearing date set by the city.
- Notice that the request for a hearing must be in writing and filed with the City Clerk no later than three days prior to the date for termination of service.
- Any utility customer receiving a notice of account delinquency and service discontinuance shall have the right to a hearing prior to disconnection. The hearing shall be held not less than five days after the request made by the

customer. The governing body shall appoint the city clerk, the city utility superintendent, or such other suitable person or persons to conduct such hearing. At such hearing, the customer and the city shall each have the right to present such evidence as is pertinent to the issue, may be represented by counsel, and may examine and cross-examine witnesses. Formal rules of evidence shall not apply. The hearing officer(s) shall promptly make his or her findings and shall enter his or her order accordingly. Unless otherwise ordered by the hearing officer, utility service shall be discontinued the date after the date that the order of discontinuance is issued by the hearing officer. Extension of the date of discontinuance may be granted to enable the customer to make arrangements for reasonable installment payments or for other good cause shown. The hearing officer's order shall be filed by the city clerk, and a copy thereof shall be provided to the customer in the same manner as set forth in subsection (a) above. (Code 2016; Ordinance 18-01)

SECTION 2: Repeal of Conflicting Ordinances. All ordinances or sections of ordinances in conflict herewith are hereby repealed.

SECTION 3: Effective Date. This Ordinance shall take effect and be in force from and after its passage, approval and publication once in the City's official paper.

AN ORDINANCE PURSUANT TO CHAPTER XV, ARTICLE 2, SECTION 15-214 OF THE CODE OF THE CITY OF OZAWKIE, KANSAS ESTABLISHING WATER RATES WITHIN THE CITY OF OZAWKIE, KANSAS AND REPEALING ALL OTHER ORDINANCES OR PORTIONS OF ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OZAWKIE, KANSAS:

SECTION 1. Pursuant to Section 15-214 of the Code of the City of Ozawkie, water rates are hereby established as follows:

WATER RATES. (a) The rates per month for the use of city water shall be as follows:

RESIDENTIAL: INSIDE CITY

0-1,000 gallons \$17.43* per first 1,000 gallons

1,001-7,000 gallons \$2.00 per 1,000 gallons

7,001-10,000 gallons \$3.00 per 1,000 gallons

All above 10,001 gallons \$7.00 per 1,000 gallons

(*The initial rate of \$17.43 shall include a \$6.43 tower surcharge)

RESIDENTIAL: OUTSIDE CITY

0-1,000 gallons \$17.43* per first 1,000 gallons

1,001-8,000 gallons \$2.00 per 1,000 gallons

All above 8,001 gallons \$7.00 per 1,000 gallons

(*The initial rate of \$17.43 shall include a \$6.43 tower surcharge)

BUSINESS, COMMERICAL AND SCHOOLS

0-1,000 gallons \$30.74* per first 1,000 gallons

1,001-10,000 gallons \$5.00 per 1,000 gallons

All above 10,001 gallons \$10.00 per 1,000 gallons

(*The initial rate of \$30.74 shall include a \$6.43 tower surcharge)

SECTION 2. REPEAL OF CONFLICTING ORDINANCES. All ordinances or parts or Sections of Ordinances in conflict herewith are hereby repealed.

SECTION 3. EFFECTIVE DATE. This Ordinance shall take effect and be in force from and after its publication in the official City Newspaper.

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF OZAWKIE, KANSAS: INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES", EDITION OF 2018 AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OZAWKIE, KANSAS:

SECTION 1. INCORPORATING STANDARD TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Ozawkie, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordinance for Kansas Cities", Edition of 2018, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as may be hereafter modified or changed. No fewer than three (3) copies of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 2018-04", with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge, and all administrative departments of the City charged with enforcement of the Ordinance shall be supplied, at the cost of the City, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

SECTION 2. EFFECTIVE DATE. This Ordinance shall take effect and be in force from and after its publication in the official city paper as provided by law.

SECTION 1. Pursuant to Section 15-338 of the Code of the City of Ozawkie, sewer rates are hereby established as follows:

SEWER RATES. (a) The rates per month for the use of city sewer shall be as follows:

RESIDENTIAL: INSIDE CITY

\$67.50/month - Composed of a \$28.50 sewer fee and \$39.00 sewer debt fee

RESIDENTIAL: OUTSIDE CITY

\$87.50/month - Composed of a \$38.50 sewer fee and \$49.00 sewer debt fee

BUSINESSS

\$67.50/month - Composed of a \$28.50 sewer fee and \$39.00 sewer debt fee

SCHOOLS

\$113.50/month - Composed of a \$50.00 sewer fee and \$63.50 sewer debt fee

SECTION 2. REPEAL OF CONFLICTING ORDINANCES. All ordinances or parts or Sections of Ordinances in conflict herewith are hereby repealed.

SECTION 3. EFFECTIVE DATE. This Ordinance shall take effect and be in force from and after its publication in the official City Newspaper.

No fewer than three (3) copies of the said Uniform Public Offense Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 2018-05", and which shall be attached a copy of this Ordinance and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

SECTION 2. EFFECTIVE. This Ordinance shall take effect and be in force from and after its publication in the official city newspaper.

ORDINANCE NO. 2018-06

AN ORDINANCE PURSUANT TO CHAPTER XV, ARTICLE 4, SECTION 15-417 OF THE CODE OF THE CITY OF OZAWKIE, KANSAS ESTABLISHING SOLID WASTE RATES FOR THE CITY OF OZAWKIE, KANSAS AND REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OZAWKIE, KANSAS:

SECTION 1. Pursuant to Section 15-417 of the Code of the City of Ozawkie, the fee schedule of the City of Ozawkie is hereby amended to establish amended sewer rates as follows:

FEE SCHEDULE. The fee for each residential unit of city solid waste collection service shall be \$13.78 per month, plus a processing fee of \$.87 for a total collection fee of \$14.65.

SECTION 2. This increase in fees shall take effect on December 1, 2018 and shall be billed at that rate thereafter.

SECTION 3. This ordinance shall take effect and be in full force from and after its passage, approval and publication as provided by law.
