## New Business

a) LRS Contract Review

LRS is request a $5 \%$ price increase on their trash services bumping the price from $\$ 16.55$ to $\$ 17.37$. The mayor recommends adjusting the current price charged to residents from $\$ 17.65$ to $\$ 18.50$ to reflect this increase in service cost. A motion to empower the mayor to sign an ordinance stating this rate change was made by Kevin Klenklen and was seconded by Laci Heller. The motion passed unanimously.
b) Purchase of Snow Blade

The city is requesting the purchase of a new snow blade for the dump truck at a price of $\$ 9300$. A motion to approve this purchase was made by Kevin Klenklen and was seconded by Chris Feuerborn. The motion passed unanimously.
